2023 BENTON COUNTY PUBLIC WORKS DUST CONTROL APPLICATION
(for Public right-of-way only)

Benton County does not provide dust control treatment for gravel roads; however, we do coordinate citizen-paid dust control treatment. It is the citizen's responsibility to install and maintain their site flagging until the dust treatment has been completed.

Flagging shall be placed at the start of your treatment area (closest to MP 0.00) with: WHITE with BLUE STRIPE for Lignin. Flagging is to be placed at the end of the treatment (furthest from MP 0.00) with: BLACK with YELLOW STRIPE for Lignin. The dust control application will be centered in the travel way, and will not exceed your paid requested length beginning from the start flag. Only paid requests will be completed. Final date for payment is May 1, 2023 & installation of flagging is Monday, May 8, 2023.

The dust treatment will be applied at recommended rates and may be applied in multiple reduced applications to enhance quality of the treatment. Rate of treatment shall be one-half (0.50) gallon per square yard for Lignin. Durability is subject to weather and/or traffic volume and is not guaranteed by the County. All treatment areas are subject to routine gravel road maintenance activities (grading and surface rock replacement) as determined by Benton County Public Works. ALL WORK IS WEATHER PERMITTING.
