## BENTON COUNTY SPECIAL TRANSPORTATION ADVISORY COMMITTEE MEETING MINUTES September 25, 2018

#### 1. Introductions

Vice-Chair Tim Bates called the meeting to order at 1:40 PM. Committee members present introduced themselves, along with guest speaker Alicia Lucke from Oregon Cascades West Council of Governments (OCWCOG). Mr. Bates also acknowledged that member Axel Deininger was present via speakerphone.

#### 2. Review and Approval of Minutes

The Committee reviewed the June 26<sup>th</sup>, 2018 minutes. Steven Black moved to accept the minutes as submitted. Tim Bates seconded the motion and all Members approved.

#### 3. Old Business:

<u>Update on HB2017 Transportation Bill Activities</u> — Lee Lazaro informed the Committee that back in July he had applied for the nationwide competitive Federal 5339 grant for replacement vehicles, and was awarded (3) 12 X 2 cutaways vans. He also noted that the three new minivans arrived and are in the process of being placed into service with the provider (Dial a Bus).

Mr. Lazaro announced that the new Statewide Transportation Improvement Fund (STIF) Committee held their first meeting on Friday, September 21<sup>st</sup>, 2018. They will meet the first Monday each month and third Friday, as necessary, with the next meeting on Monday, October 1<sup>st</sup>.

#### 4. Informational:

a) <u>Reconfigured OCWCOG Senior Companion Program</u> — Guest speaker Alicia Lucke provided information and applications regarding the newly reconfigured Senior Companion Program through Oregon Cascades West Council of Governments (OCWCOG). Ms. Lucke explained various programs that are offered with

Volunteers and Advocacy Services, with special focus on this program. Among the programs that Alicia is responsible for are:

- Disability Services Advisory Council (DSAC)
- Foster Grandparent Program (FGP)
- Money Management Program
- Retired and Senior Volunteer Program (RSVP)
- Meals on Wheels
- Meals on Wheels Advisory Committee (MOWAC)
- Meals on Wheels Volunteers
- Senior Services Advisory Council (SSAC)
- Senior Health Insurance Benefits Assistance (SHIBA) Program

Federal approval was received at the end of June 2018 for \$117,000 (\$55,000 designated for stipends for volunteers) and became effective July 1, 2018. She provided pamphlets for programs that serve Linn, Benton, and Lincoln counties.

Alicia currently has 14 of the 20 volunteers required, so she is recruiting more, hoping to obtain contacts in Alsea, Monroe, Philomath, and Adair Village for outreach in those areas. Alicia is expecting to be operating the program at full-capacity within 1½ years, and to meet program requirements including maintaining thresholds and the volunteer base.

Ms. Lucke informed the Committee that program volunteers are required to be at least 55 years of age, have an interview, pass a background check, complete training, driver training, and orientation. Volunteers will be paid a minimal salary of \$2.65 per hour and reimbursed mileage up to maximum of 500 miles per month.

Referrals are being received at this time from review of OCWCOG client needs and qualifications, including medical care, mobility issues, those whom prefer not to ride public transit, needs companionship, etc. She stressed that being low-income is NOT a determining factor to be eligible for the Senior Companion Program.

b) New Northwest Connector Website – Lee Lazaro presented the new live version of the Northwest Connector website. This website was just awarded "best website" by the National Rural Transportation Assistance Program, for websites serving small town/rural communities. He maneuvered through various features of the site and demonstrated how to use the interactive map, trip planner, event calendar, select different areas of interest, along with how the connections provide service to several counties.

- **b)** Benton County Transportation System Plan a final Draft of the TSP is now being worked on by the consultant. The Draft will be brought back to the STAC for an overview, by staff.
- c) <u>ODOT & BenCo Transit Asset Management Plan Transit Safety Plan</u> Tim Bates and Lee Lazaro are both currently working on their Transit Asset Management plans. More to follow on this topic.
