1. Call Meeting to Order

As Chair Brauner hat not yet arrived, Vice-Chair Cook called the meeting to order at 9:03 am and attendees introduced themselves.

2. Public Comments

None

3. Approval of Minutes

December 12 and 19th Meeting minutes – no minutes provided at this meeting.

4. Review of FY23-25 Benton County STIF Discretionary Projects (see Staff Report)

Dillingham stated that during the last several meetings, the group has been focused on the STIF Formula funds. Formula funds are based on payroll- and population-based sources and are allocated to Benton County, which then reviews projects to consider use of those funds. Discretionary funds are competitive statewide and consist of "discretionary" and "inter-community discretionary".

Scherf reviewed the statutory authority for review of these projects, as described in Oregon Revised Statutes (ORS). ORS requires Formula projects to be recommended to the Oregon Department of Transportation (ODOT) by a local "governing body" (Benton County Board of Commissioners). However, the governing body is not a party to the decision process for Discretionary projects and STIF Committees make a recommendation to ODOT, which then has its own review process. Ultimately, the Oregon Transportation Commission makes the final allocation decisions on both categories of projects.

The recommendation from the STIF Committee to ODOT is a thumbs up/thumbs down for each project based on the criteria in the ORS. Staff noted that all these projects meet those criteria. In response to a question about whether the Committee is meant to prioritize the projects. Scherf affirms that they are, though it's not a necessity.

This cycle, there are three applications for discretionary grants within Benton County. The first is from Albany Transit System, which put in for a bus replacement for the Linn Benton Loop, the second is Benton County seeking replacement vehicles, and the third is the OSU and LBCC Mobility Hub construction. Applicants were asked to present their projects.

1) Albany Transit, Linn Benton Loop - Bus replacement for Linn-Benton Loop service (\$900,000) Presenter: Barry Hoffman

ATS/LBCC Loop submitted a STIF discretionary application for a replacement bus, Category A, 35 ft. hybrid/electric bus. It would be the first low emission bus for the Loop. This bus would replace one that was purchased in 2010 which is currently used as a stand-by vehicle. The match for this bus was requested through Formula funds. The \$180,000 total match (assuming a 20% match) was requested as a split between the Benton County and Linn County Qualified Entities, \$90,000 each.

Committee Member Rabinowitz asked if it's possible to get bike racks that hold three bicycles, as he knows there is a demand for more capacity. Hoffman responded that he intends to purchase 3-position racks. In response to a question, Hoffman stated that a 35-foot bus is preferable to a 40-foot one, for easier maneuverability. The 40-foot buses hold just six additional people.

Committee Member Williams asked about vehicle availability. Hoffman stated he will purchase the vehicle though the State of Oregon purchasing contract. While it's unknown what the situation will be when he is ready to order, he has heard it was at least 18 months from the time or order to the time of delivery.

2) Benton County – Vehicle Purchase (\$700,000) Presenter: Brad Dillingham

Dillingham explained that Benton County is applying for four replacement vehicles. One is a Category D vehicle, likely a 25-30 ft. cutaway bus, to be used for the Coast to Valley Express or 99 Express. The other three are Category E, which would replace some smaller vehicles, primarily used for BAT Lift and ADA Paratransit services. All vehicles would be wheelchair accessible. Initially, Benton County planned to ask for five vehicles with a total cost of \$1,015,000. To be more competitive, a larger Category C vehicle was removed, leaving a total cost of \$770,000. A related Formula project request would provide a 20% match. There is enough funding available to order hybrid/electric models for the three smaller vehicles. In response to a question from Rabinowitz, Dillingham noted that there are no hybrid/electric buses within our price range, nor does the County currently have the infrastructure for fully electric vehicles.

Williams asked if BAT is looking towards electrification in the future. Dillingham replied that we could look for a funding opportunity for the infrastructure. Stockhoff shared that the Board of Commissioners is committed to electrifying as well, but the lead time on some of those vehicles is prohibitive for our operational needs, with some vehicles on order even getting canceled entirely. Bates affirmed that these delays were not uncommon.

Chair Brauner arrived late and apologized for doing so, then assumed his role as Chair for the meeting.

3) Oregon Cascades West Council of Governments OSU/LBCC Mobility Hub – (\$3,000,000) Presenter: Nick Meltzer

Committee Member Meltzer explained that the total Discretionary grant request is for \$3 million and includes both mobility hubs, \$1.5 million for each campus. A prior Discretionary grant funded the project to a 60% design, and they hope to receive this one to complete design and construction.

Rabinowitz opined that he finds both projects to be primarily cosmetic and serving only students. He continued that OSU could spend its own money to serve students and that he planned to vote against this request. Meltzer responded that the money funding these grants comes from employees in the region. It is State money and these mobility hubs connect services that cross the entire region, both east-west and north-south. The Coast to Valley Express will use it, Linn Benton Loop, Corvallis Transit System, Philomath Connection, and private bus services. He stated he does not believe it will serve just students.

Committee Member Perrells asked if any thought was given to placing the hub at Reser Stadium, rather than in this location. Meltzer explained that the location was chosen due to the existing services already servicing that stop, as noted above. Williams added that an OSU campus vision document identified this as an optimal location for a mobility hub. The intent of the project is to provide not just aesthetic appeal, but transit user amenities to encourage transit use. OSU is trying to discourage staff from driving to campus and students from bringing cars to Corvallis from other locations, so there are higher level goals this project is intended to address. Scherf stated that 10 years ago, before Meltzer's time at OCWCOG, their office did a study to determine the best locations for mobility hubs adjacent to campus. The study concluded these would be at 26th and Jefferson (in the middle of campus), this location, or 26th and Monroe.

Dillingham stated that the Coast to Valley Express, a service of Benton Area Transit, currently stops inside the McNary lot, the location of the planned mobility hub. As noted already, there are CTS, Loop and other bus stops in the area, and this mobility hub would conveniently consolidate all the stops into one location.

Rabinowitz opined it would be more reasonable for the university to start taking steps right now without this big expenditure, by first of all getting rid of the parking and putting bus stops in there. Covered benches and extra bike parking could be added to demonstrate this is valuable. He still doesn't see this project as a valuable investment. Williams explained that OSU has already done that and there is no longer parking in that pull through area. Dillingham reiterated that the Coast to Valley has a stop within the former parking lot. Williams stated that there is conversation happening right now with Groome Transportation about moving from the Hilton Garden Inn location to this one.

Committee Member Perrells asked if the mobility hub will also be a transfer station for drivers to change shifts and Scherf responded no. There aren't facilities such as a break room, restrooms, or driver parking to accommodate that use.

Committee Member Gescher asked about the LBCC part of the project. Meltzer explained that the match funding from Formula funds has been set aside by the Linn County STIF Committee, which reviewed the mobility hub Discretionary grant application last week but did not send a recommendation forward. Scherf said it's not clear what would happen if one hub location was recommended, but not

both. Gescher said he thinks it's a good project, but wondered if a \$3 million ask in a statewide fund of \$23 million might be a heavy lift.

The Committee had a discussion about how to prioritize the projects. Chair Brauner suggested the Committee let ODOT know we thought all the projects were worthy and high priority, and that the Committee had a hard time prioritizing them. Scherf stated that as staff, if she had to determine highest priority, it would be for the bus replacements. If pressed for prioritization, Brauner said his would be: 1 - Benton County vehicle replacements, 2 - mobility hub, and 3 - Linn Benton Loop bus replacement. Rabinowitz would put the Benton County vehicle replacements as first priority, Linn County bus replacement as second priority, and would remove the Mobility Hub from the list entirely. He again noted his objection to the cost of the hub and his belief that it's a cosmetic project. He said he understands not everyone agrees, but wants his opinion noted. Brauner disagreed about removing the Mobility Hub project but could see it ranking third. Williams agreed with Chair Brauner that we should let ODOT decide the prioritization, but said that if the Committee wants to prioritize them, she would agree with Chair Brauner's order.

Committee Member Gescher moved to support all three projects assuming they meet the criteria; Committee Member Williams seconded. Committee Member Rabinowitz stated he wants to separate the projects and if they aren't, he will vote no on all three. Chair Brauner stated that members have the choice to vote no, but there is already a motion before the group to support all three. The motion passed by a 5-1 vote, with Committee Member Rabinowitz voting no.

Chair Brauner asked the Committee about a preference on prioritizing the projects. Committee Member Williams made a motion to not prioritize the projects and Committee Member Rabinowitz seconded. The motion passed 4-2. Chair Brauner stated he wants it noted that the majority of the Committee believed all three projects are valuable and should be funded.

Bates expressed his thanks to Committee Member Williams, who is leaving OSU employment. The Committee wondered if the education representative has to be from OSU and Scherf said it does not.

4) Adjournment: The meeting adjourned at 10:05 am.

Background

As the operator of Benton Area Transit (BAT), a public transit service using Federal Transit Administration (FTA) funding, Benton County is required to keep an updated Title VI Plan that is reviewed at least every three years. Due to the Covid-19 pandemic, our scheduled review was delayed by the FTA and has now been prepared by staff. From the FTA circular guiding agencies in preparing Title VI Plans:

Title VI is a Federal statute and provides that no person shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financing assistance.

Title VI Plan Update

Since the 2017 Title VI Plan was adopted by Benton County, results of the 2020 United States census indicates that the percentage of individuals in Benton County speaking both the Cantonese and Mandarin languages are high enough to exceed "safe harbor thresholds." Therefore, some documents must be translated into the both Traditional and Simplified Chinese, which are the written languages associated with Cantonese and Mandarin. That knowledge is reflected in this update to the Title VI Plan and represents the most significant change to the Plan. Further, the Benton County Equity, Diversity, and Inclusion Coordinator has reviewed the draft and suggested edits in various places to provide more inclusive wording. The draft attached for the Committee's review has been updated to reflect both of these.

Following review by the STIF Committee, a recommendation will be provided to the Benton County BOC for action. Once adopted, it will be sent to our representatives at the Oregon Department of Transportation and the Federal Transit Administration. Title VI Complaint Procedures

Benton County has a standard process for investigating all complaints. Members of the public may file a signed, written complaint up to one hundred eighty (180) days from the date of alleged discrimination. Full procedures for filing a complaint and the County's procedures for investigating complaints can be found as **Attachment B**. At a minimum, the complaint shall include the following information:

- Name, mailing address, and how to contact complainant (i.e., telephone number, e-mail address, etc.)
- How, when, where, and why complainant alleges s/he was discriminated against. Include the location and names and contact information of any witnesses.
- Other significant information.

Record of Title VI investigations, Complaints, or Lawsuits

Benton County will maintain a list of any and all transit related Title VI investigations, complaints, and lawsuits. As of 8/17/2023, no Title VI Complaints have been filed since the last Title VI Program Update in 2017.

Title VI Public Participation Plan

Benton County shall strive to include community members from underrepresented groups and individuals with Limited English Proficiency (LEP individuals) in its decision making processes. This includes outreach to communities in Benton County and its surrounding area through various forms of communication and outreach.

Based on the need for alternate language services, and considering the limited budget of the Benton County programs, other activities and services that will be developed in the next three years include:

- Transit surveys conducted by Benton County will be available in English, Spanish, and Traditional and Simplified Chinese
- Future route maps will be available in English, Spanish, and Traditional and Simplified Chinese
- o Local translation services will be contacted and, if feasible, placed on retainer

Benton County's outreach and marketing initiatives have yielded a list of community organizations that serve populations with limited English proficiency. The following list of community organizations will be contacted to assist in gathering information and see what services are most frequently sought by the LEP population:

- Corvallis Public School District
- Benton County Health Department
- Hispanic Advisory Council
- o Corvallis Area Chamber of Commerce
- Casa Latinos Unidos

In addition to these activities, BAT will continue to encourage public participation, especially from LEP communities, using the following strategies:

- Scheduling meetings at times and locations, preferably accessible by public transit, that are convenient and accessible for minority and LEP communities
- Using different meeting formats through virtual and in-person settings
- Coordinating with community- and faith-based organizations, educational institutions, and other culturally specific organizations to implement public engagement strategies that reach out specifically to members of traditionally underserved and LEP communities
- As appropriate, using radio, television, or newspaper ads on stations and in publications that serve LEP populations.
- Providing opportunities for public participation through means other than written communication, such as personal interviews or use of audio or video recording devices to capture oral comments



Summary of Ongoing Public Participation Efforts and Outreach

Since the last Title VI reporting submission, Benton County conducted the following public outreach and involvement activities:

In accordance with Oregon public meeting law, all public meetings including transportation planning meetings are open to the general public. Accommodations are available for those with limited English proficiency if requested in advance of the meeting.

General Awareness and Phone Surveys

Benton Area Transit conducts onboard rider and general awareness surveys periodically, and Benton County conducts community surveys at regular intervals. The most recent community survey was conducted in 2020 and was available in English and Spanish. Future community surveys and transit surveys will be available in English, Spanish, and Traditional and Modified Chinese.

Outreach to Limited English Proficiency Individuals and Communities

Benton County utilizes language service contracts that assist in providing translation and interpretation services for languages spoken throughout the County and surrounding areas.

Schedules translated in Spanish

The current service schedule includes a section that has been translated into Spanish. New service schedules will be provided in English, Spanish, and Traditional and Simplified Chinese and made available via paper brochures and on the Benton Area Transit website.

Primary recipients and monitoring sub recipients

Benton Area Transit does not have subrecipients at this time. However, BAT will continue to monitor its contractor for services for compliance with these provisions.

Title VI Equity Analysis

There are no current planned facilities or construction projects that require a Title VI equity analysis.

Benton Area Transit strives to provide equitable service availability to customers within the service area.

Distribution of Transit Amenities

Benton Area Transit has a policy to distribute transit amenities equally across the system. Any new amenities will be distributed equally across the system without regard to race or national origin of users from that service area. This applies to:

- Seating and benches at stops and stations
- Bus shelters
- Provision of information including maps, route maps, and schedules



• Waste receptacles

Vehicle Assignment

Benton Area Transit sets a policy of vehicle assignment without regard to race, color, national origin, religion age, marital status, sexual orientation, or disability of users from that service area. All Benton County-owned vehicles are ADA-Accessible. Age of the vehicles will only be considered a factor when assigning vehicles to longer-distance routes. Vehicle size is considered depending on the expected level of demand for service.

NON-DISCRIMINATION POLICY STATEMENT

August 23, 2023

Under Title VI of the Civil Rights Act of 1964 and related authorities:

"No person in the United States shall, on the grounds of race, color, sex, age, limited English proficiency, disability, income level, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance."

Benton County is committed to complying with the requirements of Title VI in all of its programs and activities. Questions and complaints may be reported to Title VI Coordinator, at 541-766-6700; by email to BAT@co.benton.or.us; or by letter to 360 SW Avery Ave, Corvallis, OR 97339.



Attachment B

Discrimination Complaint Procedure

- 1. Any person who believes that he or she, has been subjected to discrimination prohibited by the Americans with Disabilities Act (ADA) or Title VI of the Civil Rights Act of 1964, may file a complaint with Benton Area Transit (BAT). A complaint may also be filed by a representative on behalf of such a person. All complaints will be referred to the Benton County Title VI Coordinator for review and action.
- 2. In order to have the complaint considered under this procedure, the complainant must file the complaint no later than 180 days after: a) The date of alleged act of discrimination; or b) Where there has been a continuing course of conduct, the date on which that conduct was discontinued. In either case, the Title VI Coordinator may extend the time for filing or waive the time limit in the interest of justice, as long as the Title VI Coordinator specifies in writing the reason for so doing.
- 3. Complaints shall be in writing and shall be signed by the complainant and/or the complainant's representative. Complaints shall set forth as fully as possible the facts and circumstances surrounding the alleged discrimination. In the event that a person makes a verbal complaint of discrimination to an officer or employee of Benton County, the person shall be interviewed by the Benton County Title VI Coordinator. If necessary, the Title VI Coordinator will assist the person in reducing the complaint to writing and submit the written version of the complaint to the person for signature.
- 4. Within 30 days, the Benton County Title VI Coordinator will acknowledge receipt of the allegation, inform the complainant of action taken or proposed action to process the allegation, and advise the complainant of other avenues of redress available, such as ODOT and FTA.
- 5. If the Complainant is not satisfied with the outcome of the investigation, they may appeal the decision. An appeal may be initiated by advising BAT, or specifically, the Title VI Coordinator in writing or by phone call that an appeal is requested.
- 6. Any appeal will be heard by Benton County Benton County Public Works Director. The Complainant will be contacted for more information as to why they were not satisfied with the outcome of the Complaint. All evidence will be reviewed by the secondary investigators, and a new decision issued.
- 7. The recipient will advise ODOT of all allegations. Generally, the following information will be included in every notification to ODOT:
 - a. Name, address, and phone number of the complainant.
 - b. Name(s) and address(es) of alleged discriminating official(s).
 - c. Basis of complaint (i.e., race, color, or national origin)
 - d. Date of alleged discriminatory act(s).
 - e. Date of complaint received by the recipient.



- f. A statement of the complaint.
- g. Other agencies (state, local or Federal) where the complaint has been filed.
- h. An explanation of the actions Benton County has taken or proposed to resolve the issue in the complaint.
- i. Within 90 days of receipt of the complaint, the Benton County Public Works Director will notify the complainant in writing of the final decision reached, including the proposed disposition of the matter. The notification will advise the complainant of his/her appeal rights with ODOT, or FTA, if they are dissatisfied with the final decision rendered by Benton County. The Public Works Director will also provide ODOT and/or FTA with a copy of this decision and summary of findings upon completion of the investigation.
- 8. In the event the Complainant is not satisfied with the outcome of an appeal, or if he/she wished to file a complaint directly to an outside agency, contacts for the different Title VI administrative jurisdictions are as follows:

BENTON COUNTY LANGUAGE ACCESS PLAN (LAP) FOR LIMITED ENGLISH PROFICIENCY RIDERS AUGUST 17, 2023

Benton County is required to take responsible steps to ensure meaningful access to the benefits, services, information and other important portions of our programs and activities of individuals who are Limited English Proficient (LEP). Benton County performed a four factor analysis of our contact with the public to determine the appropriate mix of LEP services to offer.

Four Factor Analysis:

Factor 1: The number or proportion of LEP persons in the service area.

Step 1: Prior experience with LEP individuals. Since the 2017 update, our dispatchers have taken less than 10 phone calls from LEP persons which have required the use of an interpreter. Additionally, drivers have reported a limited number of LEP persons within the same timeframe.

Two languages groups in the County had met the threshold of over 1,000 individuals or 5% of the overall population that speak English "less than very well." Those languages are Spanish, Cantonese, and Mandarin. While Spanish was a threshold language in the most recent Title VI Program, Cantonese and Mandarin are new language groups to meet this threshold.

Factor 2: The frequency with which LEP individuals come into contact with the service.

Benton County serves LEP persons daily through transit and paratransit services. Since the 2017 Title VI Plan Update, our records indicate that dispatchers have taken less than 10 phone calls from LEP persons in our area that required the use of an interpreter. Additionally, drivers have reported a limited number of instances where an LEP individual requested this service. This can be due to a lack of awareness within the LEP community about language services that may be available to them.

Factor 3: The importance of the service to LEP persons.

Benton County provides important transit services to the public through its fixed route and demand-response programs. Benton Area Transit provides a link between residential areas, commercial centers, healthcare facilities, educational campuses, offices, grocery stores, parks, and other community resources. Language barriers would most affect users of the demand-response services as reservations for these services are taken via telephone. Demand-response services provide approximately 49% of the total rides provided by Benton Area Transit.

Factor 4: The resources available to the recipient of the federal funds to assure meaningful access to the service by LEP persons.

Benton Area Transit currently provides some information in Spanish through bus schedules, the transit website, and information on the buses. Benton County maintains a language services liaison in each department and contracts with translation and interpretation services. BAT also contracts with Language Line Solutions to assist LEP individuals with phone inquiries.

As Cantonese and Mandarin were new additions to the LEP plan upon reviewing the most recent Census Data, Benton County is now working to address the needs of Cantonese and Mandarin speakers, through the contracted language service provider.

Designation of Vital Documents

Given the limited resources of BAT, and the small number of documented instances where language assistance was requested or needed, BAT will limit its designation of Vital Documents to be translated into all threshold languages as the following: Title VI Notice; Combined ADA/Title VI Complaint Form; and the ADA/Title VI Complaint Process.

Processes for providing language assistance services by language:

Based on the four-factor analysis, Benton Area Transit recognizes the need to continue providing language services. A review of Benton County's relevant programs, activities and services that are being offered by the County as of August, 2023 include:

For Spanish Speakers:

 The transit program uses services provided by Language Line Solutions for phone calls taken from LEP community members



- Spanish speaking interpreters who work at the County are available upon request during normal business hours if Language Line Solutions is unable to support any interpretation request
- Community surveys are available in Spanish format

For Cantonese and Mandarin Speakers:

- As these are new threshold languages, BAT will work to implement full services for these riders over the next year.
- The transit program has a contract with Language Line Solutions for phone calls taken from LEP community members
- BAT will reach out to the Language Department at Oregon State University to identify local Cantonese or Mandarin speakers who may be able to assist or contract with BAT to provide interpretation or translation services.
- o BAT will soon have vital documents translated to Traditional and Simplified Chinese.
- BAT will search for any Chinese affinity groups organizations that may aid in outreach to Cantonese and Mandarin speaking communities.

Providing notice to LEP's of language assistance

Notice will be placed on the transit buses, transit website, and on the bus schedules, and brochures announcing the availability of language assistance.

Monitoring, evaluating and updating LEP

Benton County staff will contact the community organizations that serve LEP persons, as well LEP persons themselves, and also perform a four factor analysis every three years to identify what, if any, additional information or activities might better improve transit services to assure non-discriminatory service to LEP persons. Benton County will then evaluate the projected financial and personnel needed to provide the requested services and assess which of these can be provided cost-effectively.

Training Employees

Benton County will train all employees, staff and volunteers to proficiency regarding the need and availability of language assistance to LEP individuals who use the service. Employees will be encouraged to use the services provided when communication with LEP individuals is inhibited by language barriers. This training will be provided annually and as needed.

Background

In the previous biennium (FY21-23), Benton County created and utilized a process called Unanticipated Projects of Regional Significance (UPRS) in order for Public Transportation Service Providers (PTSPs) to access unallocated funds in cases of emergency or opportunity. Prior to this biennium (FY23-25), ODOT made an adjustment to its rules, requiring that projects must already exist in the STIF Plan in order to receive additional funds from a Qualified Entity's STIF reserve funds.

City of Philomath Reserve Funds Request

In the previous STIF cycle (FY21-23), City of Philomath had a project titled, "Philomath Bus Stop Amenities," which was intended to improve bus stop locations along Philomath Connection routes. This project was not implemented due to COVID-related supply chain issues; therefore, the \$63,000 that was allocated for this project was unspent and returned to the Benton County STIF fund for the FY23-25 biennium. In the current biennium, City of Philomath has a similar project in place, titled, "PC Bus Stop Amenities," which has a budget of \$24,000.

City of Philomath is requesting that the unused money from the previous biennium (\$63,000) be applied to the new "Bus Stop Amenities" project from Benton County's reserve funds (\$695,072). At the time of applying for FY23-25 projects, it was unclear if Philomath was going to pursue the project given the status of the supply chain issues. Since then, Philomath has purchased multiple shelters and shelter amenities with the expectation that they will be able to use the current project for \$24,000 as well as the prior \$63,000.

ACTION REQUESTED

1. Review and either approve, deny, or provide recommendations to the request of using STIF reserve funds.
