## BENTON COUNTY COURTHOUSE PRESERVATION COMMITTEE (CPC)

Meeting was called to order at 4:50

**Committee Members Present:** Judy Juntunen, Peter Barnhisel, Scott McClure, Nancy Hoffman, Jill Van Buren

Staff Members Present: Paul Wallsinger, Levon Atwood

- **Administration:** The minutes for February 2020 and March 2021, were approved after the amendments to the March 2021 were noted. In Introductions and Visitor Comments, Lynne McKee's title was corrected. She is Director of Natural Areas, Parks, and Events. Also, the date for the next meeting should be changed to April 15, 2021.
- II. After approving the minutes, the committee decided to focus on a follow-up discussion of the March 2021 meeting presented by Nick Kurth, Manager of Criminal Justice System Improvement Program and Erica Ceder, DLR Historic Preservation Senior Associate. Lynne McKee, Director of NAPE, was in attendance at that meeting. It is possible under the proposed plan that the Courthouse Preservation Committee will become part of her department rather than Facilities. Currently the Committee remains under Facilities.

III. Old Business: Follow-up of Presentation at March 2021 Meeting: The Committee is aware the Courthouse needs to be retrofitted in order to meet seismic standards. The current cost for the retrofit is \$12 million. The Committee also knows that the Courthouse does not meet the needs of the justice system. The Courthouse was intended for a county with a much smaller population. Today the Courthouse is too small to adequately meet the needs of the county. The Committee fully supports building a new Courthouse that will meet those needs.

The Records and Elections Department will be moving soon to Benton County's building at 4500 Research Way in order to have all the licensing departments at one location. After the courts and the District Attorney's office move from the Courthouse, the question is, how will the Courthouse be used? Unless it can be retro-fitted it will not be safe to use.

The committee's question: How can the Courthouse Preservation Committee support funding for the new facilities while advocating for funding of the seismic upgrade for the Courthouse so it can continue to be used in some manner?
